	<p>BLUE SPRUCE Green Gas is certified by Green-e® Climate, which requires companies to provide their customers with this notice of Price, Terms, and Conditions of service. From the time you receive this, you have three business days to change your mind about purchasing Green-e Climate certified carbon offsets paired with your natural gas use from Blue Spruce Energy Services. You may cancel your agreement to purchase certified carbon offsets from Blue Spruce Energy Services by calling the customer service number or writing to the billing address listed below.</p>

<p>How will I be billed?</p>	<p>The combined charge for natural gas plus Green-e Climate certified carbon offsets will appear on your utility bill as a separate line item charge from Blue Spruce Energy Services for services in the Sempra Energy utility regions and for services in the PG&E utility region.</p>
<p>How will my bill be calculated?</p>	<p>Green-e Climate certified carbon offsets are sold to commercial and residential customers in conjunction with their monthly natural gas usage to offset their greenhouse gas emissions associated with the customer’s natural gas consumption. The greenhouse gas emissions being offset with BLUE SPRUCE Green Gas are those associated with the combustion of natural gas at the point of consumption only, and do not include lifecycle emissions that occur during extraction, production, or delivery.</p> <p>A charge of \$.679 per therm of natural gas and a monthly</p>

	<p>service fee of \$4.95 will appear on your bill. This is a fixed price per therm which includes the cost of gas and the carbon offsets. Customers are enrolled in BLUE SPRUCE Green Gas for 100% of their natural gas use.</p> <p>To calculate your carbon offset purchase in metric tons of carbon dioxide equivalent use the following calculation: # of therms of natural gas used (as listed on your monthly bill) x 0.005302. Source: www.EPA.gov/cleanenergy/energy-resources/refs.html</p> <p>This purchase is in addition to charges by the customer's natural gas utility. Customers will continue to receive a natural gas bill from their utility that includes transportation and distribution charges.</p>
<p>How much will my total natural gas commodity cost?</p>	<p>The purchase of certified carbon offsets is included in a customer's natural gas price when the BLUE SPRUCE Green Gas program is chosen.</p> <p>Example: The BLUE SPRUCE Green Gas rate is \$.679/therm. Customer consumes 60 therms per month. The natural gas charge would be \$40.74 ($\$.679 * 60 = \\$40.74$).</p> <p>Blue Spruce Energy Services is not the natural gas utility referred in the Price, Terms, and Conditions of service. Customers will still be required to pay the utility for transportation and distribution services.</p>
<p>Will my rates change over time?</p>	<p>The rates paid for BLUE SPRUCE Green Gas will be fixed for the initial 12 month term. At the time of renewal, the rate may change based on market conditions. In the event of a price or carbon offset content change, all customers will be notified and offered the option to change products or discontinue participation in the program.</p>
<p>If I want to terminate this agreement/ contract, what is the early termination fee?</p>	<p>The contract period is a minimum of one year and will be automatically renewed for an additional year unless the customer provides notice of cancellation at least 60 days prior to the anniversary date of their contract.</p> <p>An early termination charge of \$50.00 will be assessed for early termination of the contract.</p>
<p>What length of agreement/ contract is required?</p>	<p>The contract period is a minimum of one year and will be automatically renewed for an additional year unless the customer provides notice of cancellation at least 60 days prior to the anniversary date of their contract.</p>
<p>What other fees might I be charged?</p>	<p>A billing service fee may apply (depending on the billing fees charged by the applicable utility for consolidated utility</p>

billing.). A late charge of 3% for bills that are unpaid for more than 24 days may be applied.

By purchasing BLUE SPRUCE Green Gas, 100% of the greenhouse gas emissions associated with your natural gas consumption are offset with Green-e Climate certified carbon offsets.

These carbon offsets represent the reduction of a specific quantity of greenhouse gas (GHG) emissions. By purchasing these offsets, you alone have the right to all associated claims about the environmental benefits they embody. Carbon offsets are to be regarded as a real environmental commodity, not a donation or investment in a future emissions reduction project. The verified GHG emissions reductions you purchased are sourced from projects that have been validated and registered under high-quality project standards.

The Carbon Offset Content Label represents the mix of project types, locations, and verification programs that will be used to supply your offsets. The actual percentages or metric tons of GHG emissions reductions by type may vary by a small percentage. In the case of a significant variance, the Seller of the Certified Offsets is obligated to provide you with more accurate historical disclosure. Quantities of carbon offsets that are delivered over time in accordance with this purchase agreement meet Green-e Climate vintage and verification requirements. Green-e Climate verifies the delivery of these Certified Offsets each year. If Green-e Climate certification is terminated prior to the end of the term of this purchase agreement, the remainder of the quantity of Certified Offsets specified in this agreement will be delivered at the time of termination and subsequently verified by Green-e Climate, or you will be offered the option of a refund to cover any undelivered offsets.

The vintage reported indicates the year that the GHG emissions reductions occur. A range of years extending into the future indicates that offsets will be delivered over time, and so the vintage of the GHG emissions reductions will fall within this range and not exceed the year of delivery. Green-e Climate requires annual verification of deliveries under this purchase agreement. Green-e Climate also requires that disclosure of accurate vintage year be provided annually.



Green-e® Climate is an independent certification program for greenhouse gas emissions reductions (carbon offsets) sold in the voluntary market. The Green-e Climate logo identifies carbon offsets that meet the program's high environmental and consumer protection standards.
